

PRIVACY POLICY

WeFuel recognizes the importance of maintaining the privacy of the information belonging to you. This Policy sets out details of how we treat user information we collect on www.wefuel.in (the "Website"). The Website is owned and operated by GoundHogs Private Limited, a firm registered under the Companies Act, 2013 (18 of 2013) having its registered office at 23/18, Kannammal Street, Saligramam, Chennai – 600093.

By visiting and/or using the Website, you agree to the terms of this Privacy Policy and it shall be deemed that you have read in full, accepted and agreed to the terms herein. WeFuel reserves the right to modify the terms contained in this Privacy Policy at any time by posting such modifications on the Website. The modified Privacy Policy would be effective from the date of modification that is posted by WeFuel on the Website. If you do not agree to any term that is contained in this Privacy Policy, please immediately cease your use of the Website.

This Privacy Policy is issued pursuant to the provisions that are contained in (a) Section 43A of the Information Technology Act, 2000; (b) Regulation 4 of the Information Technology ((Reasonable Security Practices and Procedures and Sensitive Personal Data or Information) Rules, 2011; and (c) Regulation 3(1) of the Information Technology (Intermediaries Guidelines) Rules, 2011.

Information that is collected by WeFuel on the Website shall be used by WeFuel only for the purpose of providing the Services, and such information shall not be used, sold, transferred or rented in a manner that is not set out in this Privacy Policy.

Information that is collected by WeFuel:

- 1. Name
- 2. Email address
- 3. Mobile/Phone number/s
- 4. Address (residential/commercial)
- 5. Location details
- 6. IP address
- 7. Browser details

In providing the various services that are available on the Website (the "Services"), WeFuel may have to collect certain personal information from you. This information would, inter alia, include the following:

Contact information: WeFuel may collect your name, email, mobile number, postal address, IP address etc.

Payment and billing information. WeFuel may collect your billing name, billing address and payment method when you pay the Charges (as defined in the Terms & Conditions available



here: https://www.wefuel.in/documents/WeFuel TCs_11.02.2021.pdf) on the Website. Please note that WeFuel 's online payment partner would collect your credit/debit card number or credit/debit card expiry date or other details pertaining to your credit/debit card.

Other information. While you use the Website, WeFuel may collect information about your IP address and the browser you are using.

You acknowledge and agree that any and all information that is provided by you on the Website is provided by you voluntarily and at your own risk. While WeFuel would make all efforts to ensure the safety and security of the information provided for you, it shall not be responsible for any loss or theft of data. Please note that any information that is provided by you may be retained by WeFuel for (i) providing the Services; and (ii) for meeting its obligations under applicable law. Even if you delete your User account on Website, WeFuel may have to retain the information provided by you for a short period of time until the same can be removed from its servers, and for compliance with its obligations under law (if any).

You shall be responsible for the accuracy of the information provided to WeFuel for the use of the Website and the Services. If there is any mistake in or change to the personal information provided by you for the use of Website, you shall immediately notify WeFuel at info@wefuel.in. You shall be solely liable for the consequences of providing incomplete, inaccurate or incorrect information on the Website. Where WeFuel has reasons to believe that the information provided by you on the Website is incorrect or incomplete, WeFuel may restrict you from using the Website by disabling your User Account.

Information may be collected in several ways:

Passive Collection: This refers to the information that is gathered by WeFuel using tracking tools like Google Analytics, Google Webmaster, browser cookies etc. for collecting information about your usage of our website. This information may include the URL of the website that you visited just before visiting the Website or which one you go to after visiting the Website, your computer browser information, and your IP address.

While WeFuel does not actively collect any information from persons who visit the Website, but do not register themselves on it or avail of the Services, certain portions of this Privacy Policy would be applicable to such visitors as well.



Use of your personal information by WeFuel:

To contact you: The contact information you provide would be used by WeFuel to contact you for the confirmation of an order or for any other Service.

To improve the quality of the Services: WeFuel might use your information to improve the functionality of the Services and to ensure that its quality is maintained / better.

For security purposes: WeFuel might use the information provided by you on the Website to protect our company, our customers, or our websites.

For marketing purposes: WeFuel might send you information about special promotions or offers. WeFuel might also notify you of new or improved features on the Website.

Transactional communications: WeFuel may also contact you by way of emails or SMSs to confirm an order, confirm the payment of Charges etc.

WeFuel shall use your information only in a manner that is permitted by applicable law.

Sharing of information by WeFuel with third parties:

Service Providers: WeFuel shall share your information with persons who WeFuel has contracted with for assistance with performing the Services such as payment processors or transactional message processors.

Compliance with law: WeFuel might share your information to respond to a court order or subpoena. WeFuel may share your information if a government agency or investigatory body requests WeFuel to do so.

Mergers and Acquisitions: If WeFuel sells its business or hives of a portion of the same to a new entity, your personal information that is available on the Website may be transferred to the new entity.

SECURITY OF YOUR INFORMATION:

Please note that neither WeFuel nor any of its employees would have access to the password that relates to your User account on the Website. You shall be solely responsible for protecting your login credentials to the Website, and WeFuel shall not be liable in any manner for unauthorized use of your login credentials. You shall be liable to WeFuel for any loss suffered by WeFuel as a result of unauthorized use of your login credentials. While WeFuel shall seek to implement the best market practices and security policies for the protection of your personal information, it shall not be liable for theft or loss of data due to unauthorized access to the User's electronic devices.



Cookies: A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you grant the permission, the file is added, and the cookie helps analyze web traffic or lets you know when you visit a particular site. WeFuel uses traffic log cookies to identify which pages are being used. This helps WeFuel analyze data about web page traffic and improve the functioning of the Website. This information is used by WeFuel only for statistical analysis and then the data is removed from the system. Please note that WeFuel does not have any control over the cookies that are placed by third party links on the Website. WeFuel does not represent to you that such third-party websites have their own Privacy Policies or that the information that is provided by you to them would be secure.
